## Confirmation of Booking

All menus, wines, spirits and cocktails are subject to availability. If the chosen item is not available we will endeavour to find a suitable alternative agreeable with the client. Menu listings and prices are subject to change.

All prices quoted for food and beverages are subject to change but are inclusive of V.A.T at 20%.

12.5% service charge will be added to your final bill on any bookings of 6 people and more. A table deposit will be required upon confirmation of booking.

## Final Numbers

Putney Pies requires confirmed numbers for food, 7 working days prior to the event. This number will be considered the guaranteed minimum and will be charged for.

## **Cancellation Policy**

Putney Pies retains the right to charge a cancellation fee of the cost of the confirmed food requirements and the agreed minimum spends if 1 weeks' notice is not given prior to the event.

The Client is responsible for the orderly conduct of the guests attending the event. They will be bound by Putney Pies rules, which are available upon request.
